Notice is hereby given that the Zoning Board of Appeals will hold a public hearing on Thursday, July 26, 2007 at 6:30 p.m. in Memorial Hall, 1196 Main Street on the Petition of The Richmond Company for property located at 4 - 6 Holt Road, 1147 Main Street and 1133 Main Street for **VARIANCES** from the requirements of Chapter 7.1 VIII C (5)(f) of the Zoning Bylaw to allow entrance or exit driveways on Main Street for a non-residential use to be closer than 175 feet from an intersecting street, to allow an entrance or exit driveway on Holt Road for a non-residential use to be closer than 100 feet from an intersecting street, to allow more than 2 driveways to serve any one lot and from the requirements of Chapter 7.1 VIII (5)(h) of the Zoning Bylaw to allow an entrance and exit on Main Street to exceed 20 feet in width at its intersection with the front lot line.
